






WP 2021-2022 - note

EOSC Procurement Action 2021- 22

- Type of Action: Public procurement
- Indicative timetable: Fourth quarter of 2022
- Indicative budget: EUR 35.00 million from the 2022 budget
- Indicative contract duration: 36 months



The date of publication of the EOSC Procurement's contract notice has been delayed.

The procurement is still expected to be launched before the end of 2022 and submission deadlines will be adjusted accordingly.
